LEGAL DESCRIPTION
TEMPORARY CONSTRUCTION EASEMENT
PARCEL 31
AIRPORT ROAD IMPROVEMENTS
ROCKWALL, ROCKWALL COUNTY, TEXAS

BEING 0.038 acre of land located in the E.M. ELLIOTT SURVEY, ABSTRACT No. 77, Rockwall, Rockwall County, Texas, and being a portion of the tract of land conveyed to Clifford Cornelius and, Jeanette L. Cornelius, by the deed recorded in Volume 1397, Page 172, of the Deed Records of Rockwall County, Texas. Said 0.038 acre of land being more particularly described by metes and bounds as follows:

BEGINNING at a ½" iron rod stamped "Brittain & Crawford" set, in the West boundary line of said Cornelius Tract, lying S 00° 31' 37" E 40.08 feet, from a "PK" nail found marking the Northwest corner of said Cornelius Tract. Said Point of Beginning lying in the new South right-of-way line of Airport Road;

THENCE N 89° 26' 31" E 114.68 feet, along the new South right-of-way line of said Airport Road, to a ½" iron rod stamped "Brittain & Crawford" set, in the East boundary line of said Cornelius Tract;

THENCE S 00° 31' 33" E 15.14 feet, along the East boundary line of said Cornelius Tract, to a point;


THENCE N 89° 40' 53" W 114.70 feet, to a point in the West boundary line of said Cornelius Tract;


