**LEGAL DESCRIPTION**  
**TEMPORARY CONSTRUCTION EASEMENT**  
**PARCEL 7**

BEING 0.030 acre of land located in LOT 1, GREENLEE ADDITION, to the city of Rockwall, Rockwall County, Texas, according to the plat recorded in Cabinet 'A', Slide 151, of the Plat Records of Rockwall County, Texas. Said 0.030 acre of land being more particularly described by metes and bounds as follows:


BEGINNING at a ½" iron rod stamped "Brittain & Crawford" set in the West boundary line of said Lot 1, and lying N 00° 01' 28" E 17.84' feet from a "PK" nail found, marking the Southwest corner of said Lot 1, Said Point of Beginning lying in the new North right-of-way line of Airport Road;

THENCE N 00° 01' 28" E 5.40 feet, along the West boundary line of said Lot 1, to a point;

THENCE N 85° 29' 06" E 132.91 feet, to a point in the East boundary line of said Lot 1, lying in the West right-of-way line of Amity Lane;

THENCE S 00° 01' 28" W 14.57 feet, along the East boundary line of said Lot 1, and the West right-of-way line of said Amity Lane, to a point in the new North right-of-way line of said Airport Road;

THENCE S 89° 26' 31" W 132.50 feet, along the new North right-of-way line of said Airport Road, to the POINT OF BEGINNING, containing 0.030 acre (1,323 square feet) of land.
