- (3) 2 MØ, MØ GND. 2" SCHED. 80 PVC CONDUIT.
- (4) 2\*8, \*8 GND. 2" SCHED. 80 PVC CONDUIT.
- (5) 2\*6, \*6 GND. I" PVC CONDUIT.
- 6 LIGHTING CIRCUITS DH-1, DH-2, 4 DH-3 ROUTED THROUGH 2" SCHED. 80 PVC CONDUIT.

(3) FOR FACTORY INSTALLED VENDOR RECEPTACLE IN LIGHT POLE BASE, PROVIDE AND INSTALL (1) NEW 20A/IP CIRCUIT BREAKER (MATCH A.I.C. RATING OF EXISTING) IN EXISTING PANEL 'LA' SPACE LA-20 AND CONNECT WITH 2 S, S GND. - 34" PVC CONDUIT.

(14) FOR FACTORY INSTALLED VENDOR RECEPTACLE IN LIGHT POLE BASE, PROVIDE AND INSTALL (1) NEW 20A/IP CIRCUIT BREAKER (MATCH A.I.C. RATING OF EXISTING) IN EXISTING PANEL 'LA' SPACE LA-21 AND CONNECT WITH 2\*8, \*8 GND. - 3/4" PVC CONDUIT.

(15) FOR FACTORY INSTALLED VENDOR RECEPTACLE IN LIGHT POLE BASE, PROVIDE AND INSTALL (1) NEW 20A/IP CIRCUIT BREAKER (MATCH A.I.C. RATING OF EXISTING) IN EXISTING PANEL 'LA' SPACE LA-22 AND CONNECT WITH 2\*12, \*12 GND. - 34" PVC CONDUIT.


