1. Grantor reserves for himself the right to deepen the channel of the branch in which this easement is located to a depth which shall not be below elevation 420, mean sea level, and which right shall extend by agreement with the City of Dallas to such adjacent areas owned by the City of Dallas as may be necessary to excavate said branch to such depth; provided, however, that
in the exercise of the excavation rights mentioned in this paragraph neither
Grantor; nor his heirs, successors or assigns, shall fill or construct,
or cause to be filled or constructed, any area or structure which shall alter
in any manner the shoreline of the Forney Reservoir as shown on the date of
this agreement in the certified maps and surveys prepared by Forrest and Cotton,
Inc., Engineers, for the purpose of establishing and determining such shoreline.

- 2. Grantor, his heirs, administrators or assigns, will:
 - (a) maintain the banks of the branch to prevent erosion, and in the event he does not, it is agreed that this easement will progress with the erosion of the banks.
 - (b) abide by the rules and regulations of the lake as may be established by the City of Dallas.
- 3. The City of Dallas retains the right to refuse access to the lake proper for failure to comply with the rules, and regulations governing the use of the lake.

It is expressly understood and agreed that Grantor does hereby waive any and all damages in the future as a result of the exercise of this easement and all of the uses contained herein, which damages for any cause shall be waived forever.
