

NOTES:

THE CONTRACTOR SHALL TAKE ALL THE NECESSARY PROVISIONS FOR THE SUPPORT, PROTECTION, RELOCATION AND OR TEMPORARY RELOCATION OF ALL UTILITIES, STRUCTURES, PAVEMENT, SIDEWALKS AND LANDSCAPING ABOVE AND BELOW THE GROUND THAT INTERFERE WITH CONSTRUCTION OPERATIONS. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ALL COSTS ASSOCIATED WITH THE REPAIR AND OR REPLACEMENT IN THE EVENT DAMAGES OCCUR TO EXISTING UTILITIES, PAVEMENT, SIDEWALKS, STRUCTURES, TREES OR LANDSCAPING.
