WHEREAS, George O. Yamini Company, Inc., Trustee, is the owner of a tract of land situated in the Daniel Atkins Survey, Abstract No. 1 and the E. P. Gaines Chisum Survey, Abstract No. 64, City of Rockwall, Rockwall County, Texas, and being more particularly described as follows:

 THENCE in a southerly direction and continuing along the westerly line of said State Road 740 and along said curve, 105.10' to the place of beginning and containing 32.64 acres of land.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:
 THAT George O. Yamini Company, Inc., Trustee, does hereby adopt this plat designating the heretofore described property as Lake Ridge Park, an Addition to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon and does hereby dedicate the easement strips shown on the plat for the mutual use and accommodation of the garbage collection agencies and all public utilities desiring to use or using same. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other improvements or growths which in any way endanger or interfere with the construction, maintenance or efficiency of its respective system on any of these easement strips; and any public utility shall have at all times the right of ingress and egress to and from any of the said easement strips for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining, and adding to or removing all or parts of its respective systems without the necessity at any time of procuring permission of anyone.
