

# TIE BAR

- EITHER THE HOOK TIE BOLT OR THE TIE BAR MAY BE USED TO PROVIDE LOAD TRANSFER FOR LONGITUDINAL JOINTS.
- THE SPACING FOR EITHER TIE BARS OR HOOK TIE BARS BOTH *IS 24" C−C.*
- 3. SEE JS-03 (FW), METHOD "B" FOR JOINT SEALING DETAILS.
- 4. THIS DETAIL DOES NOT APPLY TO NEW CONSTRUCTION, STAGE CONSTRUCTION, OR BLOCKOUT (SEE CPCR STANDARDS)





TIE TO EXIST. CONC. PAVEMENT (LONGITUDINAL JOINTS)




TIE TO EXIST. CONCRETE PAVEMENT (TRANSVERSE JOINTS W/EXISTING "SLEEPER" SLAB)



# TIE TO EXIST. CONC. CURB & GUTTER

SAWING OF PAVEMENT AND REMOVAL OF EXISTING CONC. WILL NOT BE PAID FOR DIRECTLY, BUT WILL BE SUBSIDIARY TO THE VARIOUS BID ITEMS.

> DRILL #" DIA. HOLE & SECURE TIE BARS WITH TY. III EPOXY (CL. A or C). TYPE OF EPOXY AND METHODS OF CLEANING AND APPLICATION SHALL BE APPROVED BY THE ENGINEER PRIOR TO PLACEMENT.



# TIE TO EXIST. CONC. PAVEMENT

(TRANSVERSE JOINTS W/O EXISTING "SLEEPER" SLAB)

NOTE: DETAILS SHOWN APPLY WHEN MULTIPLE-PIECE TIE BARS HAVE NOT BEEN INCLUDED IN THE PREVIOUS CONCRETE PLACEMENT

## GENERAL NOTES:

TIE BARS SHALL BE GROUTED INTO THE EXISTING CONCRETE THE MINIMUM LENGTHS SHOWN, AND MUST MEET THE REQUIREMENTS OF THE PULL-OUT TEST SPECIFIED IN ITEM 361, WHEN REQUIRED BY THE ENGINEER.
