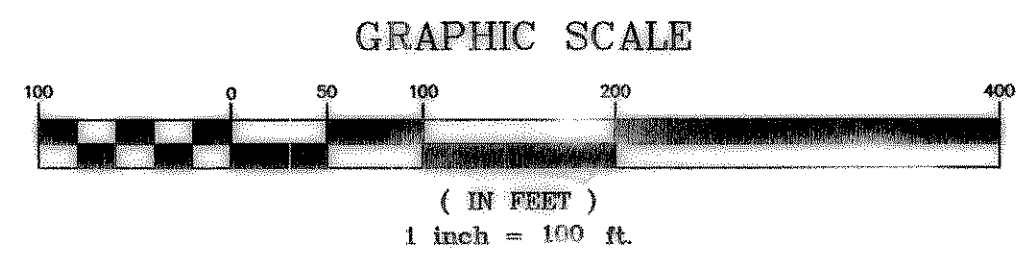

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

THAT the County of Rockwall, being owner, does hereby amend said plat solely for the purpose of creating fire lanes, drainage, and utility easements and/or relocating or abandoning part of the existing utility easement as shown hereon, provided however all utility easements are hereby dedicated for mutual use and accommodation of all public utilities desiring to use or using the same. No buildings shall constructed or placed upon, over or across the utility as shown hereon. Said utility easements being hereby reserved for the mutual use and accommodation of all public utilities desiring to use or using the same. All public utilities shall have the right to remove and keep removed all or any part of any buildings, fences, trees, shrubs, or growths which may in any way, endanger or interfere with construction, maintenance or efficiency of its respective system.
