SUB LEASE DESCRIPTION PROJECT NO. TL2004-001

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 41, BLOCK F of HILLSIDE PHASE 5 AT THE SHORES, an addition to the City of Rockwall as recorded in Cabinet D, Page 323 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 41, BLOCK F South 06 deg 55 min 43 sec East a distance of 88.21 feet to a 1/2 inch iron rod found at the most southwesterly corner of said LOT 41, BLOCK F;

THENCE departing the westerly line of said LOT 41, BLOCK F South 75 deg 21 min 09 sec West passing an "X" cut set in concrete at a distance of 273.49 feet, continuing in all a distance of 283.48 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 266.8 feet to a point for corner;

THENCE departing said 435.5 contour line North 83 deg 04 min 17 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.95 feet, continuing in all a distance of 424.20 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 1.033 acres or 44,945 square feet of land, more or less.
