SUB LEASE DESCRIPTION PROJECT NO. TL2004-009

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found at the most northwesterly corner of LOT 49, BLOCK F of HILLSIDE PHASE 5 AT THE SHORES, an addition to the City of Rockwall as recorded in Cabinet D, Page 323 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 49, BLOCK F South 22 deg 42 min 42 sec East a distance of 65.00 feet to a $\frac{1}{2}$ inch iron rod found for corner at the most southwesterly corner of said LOT 49, BLOCK F;

THENCE departing the westerly line of said LOT 49, BLOCK F South 67 deg 17 min 18 sec West passing an "X" cut set at a distance of 116.18 feet, continuing in all a distance of 126.18 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 72.4 feet to a point for corner;

THENCE departing said 435.5 contour line North 67 deg 17 min 18 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.08 feet, continuing in all a distance of 140.30 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.204 acres or 8,886 square feet of land, more or less.
