## EXHIBIT "B"

SUB LEASE DESCRIPTION PROJECT NO. TL2004-012

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 52, BLOCK F of HILLSIDE PHASE 5 AT THE SHORES, an addition to the City of Rockwall as recorded in Cabinet D, Page 323 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 52, BLOCK F as follows:

South 22 deg 42 min 42 sec East a distance of 61.66 feet to a brass—capped monument for corner;

South 29 deg 19 min 16 sec East a distance of 3.37 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 52, BLOCK F;

THENCE departing the westerly line of said LOT 52, BLOCK F South 67 deg 17 min 18 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 129.78 feet, continuing in all a distance of 140.52 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 65.3 feet to a point for corner;

THENCE departing said 435.5 contour line North 67 deg 17 min 18 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.04 feet, continuing in all a distance of 135.72 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.206 acres or 8,980 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
