SUB LEASE DESCRIPTION PROJECT NO. TL2004-027

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 52, BLOCK D of HILLCREST SHORES PHASE II, an addition to the City of Rockwall as recorded in Cabinet C, Page 276 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 52, BLOCK D South 01 deg 24 min 36 sec West a distance of 111.46 feet to a brass—capped monument found for corner at the most southwesterly corner of said LOT 52, BLOCK D;

THENCE departing the westerly line of said LOT 52, BLOCK D and along the southerly line of said LOT 52, BLOCK D South 86 deg 00 min 37 sec East a distance of 222.63 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner;

THENCE departing the southerly line of said LOT 52, BLOCK D South 74 deg 25 min 35 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 785.89 feet continuing in all a distance of 795.95 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 295.5 feet to a point for corner;

THENCE departing said 435.5 contour line North 81 deg 23 min 18 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 665.63 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 3.496 acres or 152,292 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
