SUB LEASE DESCRIPTION PROJECT NO. TL2004-031

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a ½ inch iron rod found at the most northwesterly corner of LOT 48, BLOCK D of HILLCREST SHORES PHASE II, an addition to the City of Rockwall as recorded in Cabinet C, Page 276 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 48, BLOCK D as follows:

South 15 deg 34 min 25 sec East a distance of 50.36 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner;

South 00 deg 25 min 15 sec West a distance of 52.11 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 48, BLOCK D;

THENCE departing the westerly line of said LOT 48, BLOCK D South 70 deg 12 min 16 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 315.52 feet, continuing in all a distance of 325.52 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 196.3 feet to a point for corner;

THENCE departing said 435.5 contour line North 74 deg 25 min 35 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 467.76 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 1.019 acres or 44,389 square feet of land, more or less.
