SUB LEASE DESCRIPTION PROJECT NO. TL2004-033

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 46, BLOCK D of HILLCREST SHORES PHASE II, an addition to the City of Rockwall as recorded in Cabinet C, Page 276 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 46, BLOCK D South 36 deg 54 min 42 sec East a distance of 102.08 feet to a $\frac{1}{2}$ inch iron rod found for corner at the most southwesterly corner of said LOT 46, BLOCK D;

THENCE departing the westerly line of said LOT 46, BLOCK D South 61 deg 47 min 03 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 172.34 feet, continuing in all a distance of 182.34 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 124.8 feet to a point for corner;

THENCE departing said 435.5 contour line North 65 deg 59 min 34 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 197.01 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.449 acres or 19,556 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
