SUB LEASE DESCRIPTION PROJECT NO. TL2004-034

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a ½ inch iron rod found at the most northwesterly corner of LOT 45, BLOCK D of HILLCREST SHORES PHASE II, an addition to the City of Rockwall as recorded in Cabinet C, Page 276 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 45, BLOCK D South 36 deg 54 min 42 sec East a distance of 97.61 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 45, BLOCK D;

THENCE departing the westerly line of said LOT 45, BLOCK D South 57 deg 40 min 08 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 210.94 feet, continuing in all a distance of 220.94 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 131.5 feet to a point for corner;

THENCE departing said 435.5 contour line North 61 deg 47 min 03 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 182.34 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.492 acres or 21,424 square feet of land, more or less.
