SUB LEASE DESCRIPTION PROJECT NO. TL2004-039

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 40, BLOCK D of HILLCREST SHORES, an addition to the City of Rockwall as recorded in Cabinet C, Page 199 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 40, BLOCK D South 42 deg 57 min 43 sec East a distance of 88.00 feet to 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 40, BLOCK D;

THENCE departing the westerly line of said LOT 40, BLOCK D South 55 deg 58 min 56 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 270.08 feet, continuing in all a distance of 280.08 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 58.6 feet to a point for corner;

THENCE departing said 435.5 contour line North 47 deg 02 min 17 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 256.75 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.414 acres or 18,039 square feet of land, more or less.
