SUB LEASE DESCRIPTION PROJECT NO. TL2004-041

STATE OF TEXAS

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found at the most northwesterly corner of LOT 38, BLOCK D of HILLCREST SHORES, an addition to the City of Rockwall as recorded in Cabinet C, Page 199 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 38, BLOCK D South 42 deg 57 min 43 sec East a distance of 88.00 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 38, BLOCK D;

THENCE departing the westerly line of said LOT 38, BLOCK D South 70 deg 26 min 42 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 308.48 feet, continuing in all a distance of 318.48 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 49.5 feet to a point for corner;

THENCE departing said 435.5 contour line North 63 deg 47 min 37 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 305.25 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.461 acres or 20,091 square feet of land, more or less.
