SUB LEASE DESCRIPTION PROJECT NO. TL2004-043

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a point from which an "X" cut in concrete found bears North 24 deg 08 min 12 sec East a distance of 0.60 feet, said point being the most northwesterly corner of LOT 36, BLOCK D of HILLCREST SHORES, an addition to the City of Rockwall as recorded in Cabinet C, Page 199 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 36, BLOCK D South 04 deg 15 min 47 sec West a distance of 58.69 feet to a 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 36, BLOCK D;

THENCE departing the westerly line of said LOT 36, BLOCK D South 76 deg 18 min 05 sec West passing an "X" cut set in concrete at a distance of 325.72 feet, continuing in all a distance of 335.72 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 52.9 feet to a point for corner;

THENCE departing said 435.5 contour line North 75 deg 18 min 09 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 343.50 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.407 acres or 17,710 square feet of land, more or less.
