SUB LEASE DESCRIPTION PROJECT NO. TL2004-045

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 34, BLOCK D of NORTHSHORE PHASE 2B, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 34, BLOCK D South 04 deg 11 min 32 sec West a distance of 84.00 feet to a 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 34, BLOCK D;

THENCE departing the westerly line of said LOT 34, BLOCK D South 87 deg 19 min 14 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 269.67 feet, continuing in all a distance of 279.67 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 65.8 feet to a point for corner;

THENCE departing said 435.5 contour line North 81 deg 19 min 36 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 304.89 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.443 acres or 19,307 square feet of land, more or less.
