

SUB LEASE DESCRIPTION PROJECT NO. TL2004-047

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 32, BLOCK D of NORTHSHORE PHASE 2B, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 32, BLOCK D South 04 deg 11 min 32 sec West a distance of 84.00 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 32, BLOCK D;

THENCE departing the westerly line of said LOT 32, BLOCK D North 85 deg 40 min 29 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 226.00 feet, continuing in all a distance of 236.01 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 88.9 feet to a point for corner;

THENCE departing said 435.5 contour line South 85 deg 40 min 29 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.93 feet, continuing in all a distance of 255.67 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.467 acres or 20,362 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
