SUB LEASE DESCRIPTION PROJECT NO. TL2004-055

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 22, BLOCK D of NORTHSHORE PHASE 2A, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 22, BLOCK D South 18 deg 15 min 56 sec East a distance of 84.00 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 22, BLOCK D;

THENCE departing the westerly line of said LOT 22, BLOCK D South 71 deg 44 min 04 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 74.32 feet, continuing in all a distance of 84.32 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 89.8 feet to a point for corner;

THENCE departing said 435.5 contour line North 71 deg 44 min 04 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 58.74 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.147 acres or 6,407 square feet of land, more or less.
