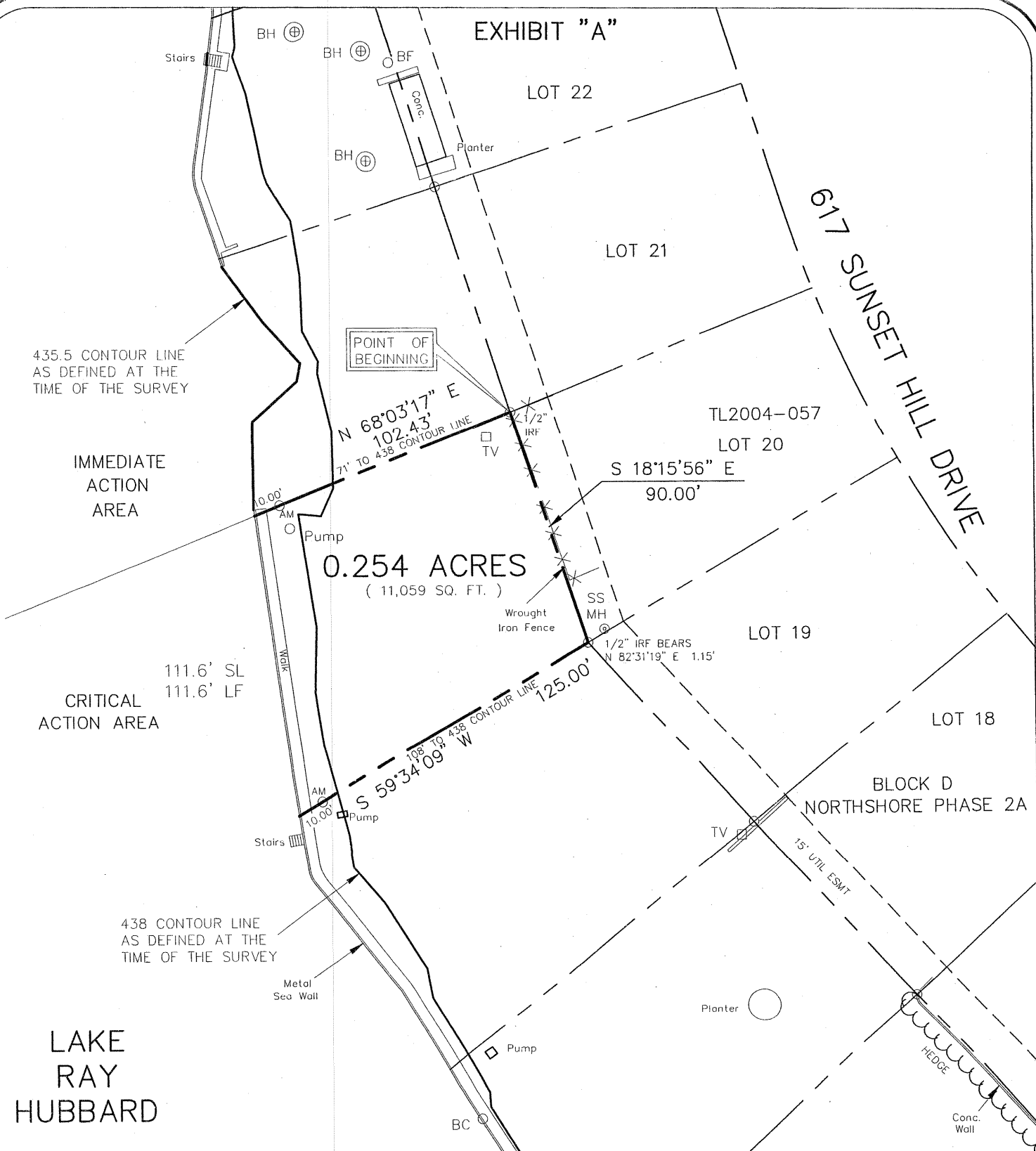
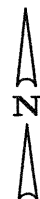

SUB LEASE DESCRIPTION
PROJECT NO. TL2004-057

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found at the most northwesterly corner of LOT 20, BLOCK D of NORTSHORE PHASE 2A, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 20, BLOCK D South 18 deg 15 min 56 sec East a distance of 90.00 feet to a point from which a 1/2 inch iron rod found bears North 82 deg 31 min 19 sec East a distance of 1.15 feet for corner at the most southwesterly corner of said LOT 20, BLOCK D;

THENCE departing the westerly line of said LOT 20, BLOCK D South 59 deg 34 min 09 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 115.00 feet, continuing in all a distance of 125.00 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 111.6 feet to a point for corner;

THENCE departing said 435.5 contour line North 68 deg 03 min 17 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 102.43 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.254 acres or 11,059 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
