SUB LEASE DESCRIPTION PROJECT NO. TL2004-061

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a point from which a 1/2 inch iron rod found bears North 01 deg 50 min 00 sec East a distance of 0.54 feet, said point being the most northwesterly corner of LOT 16, BLOCK D of NORTHSHORE PHASE 2A, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 16, BLOCK D South 42 deg 35 min 46 sec East a distance of 84.00 feet to a point from which a 1/2 inch iron rod found bears North 74 deg 20 min 56 sec West a distance of 0.52 feet for corner at the most southwesterly corner of said LOT 16, BLOCK D;

THENCE departing the westerly line of said LOT 16, BLOCK D South 47 deg 24 min 14 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 202.48 feet, continuing in all a distance of 212.48 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 98.9 feet to a point for corner;

THENCE departing said 435.5 contour line North 47 deg 24 min 14 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 196.88 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.406 acres or 17,695 square feet of land, more or less.
