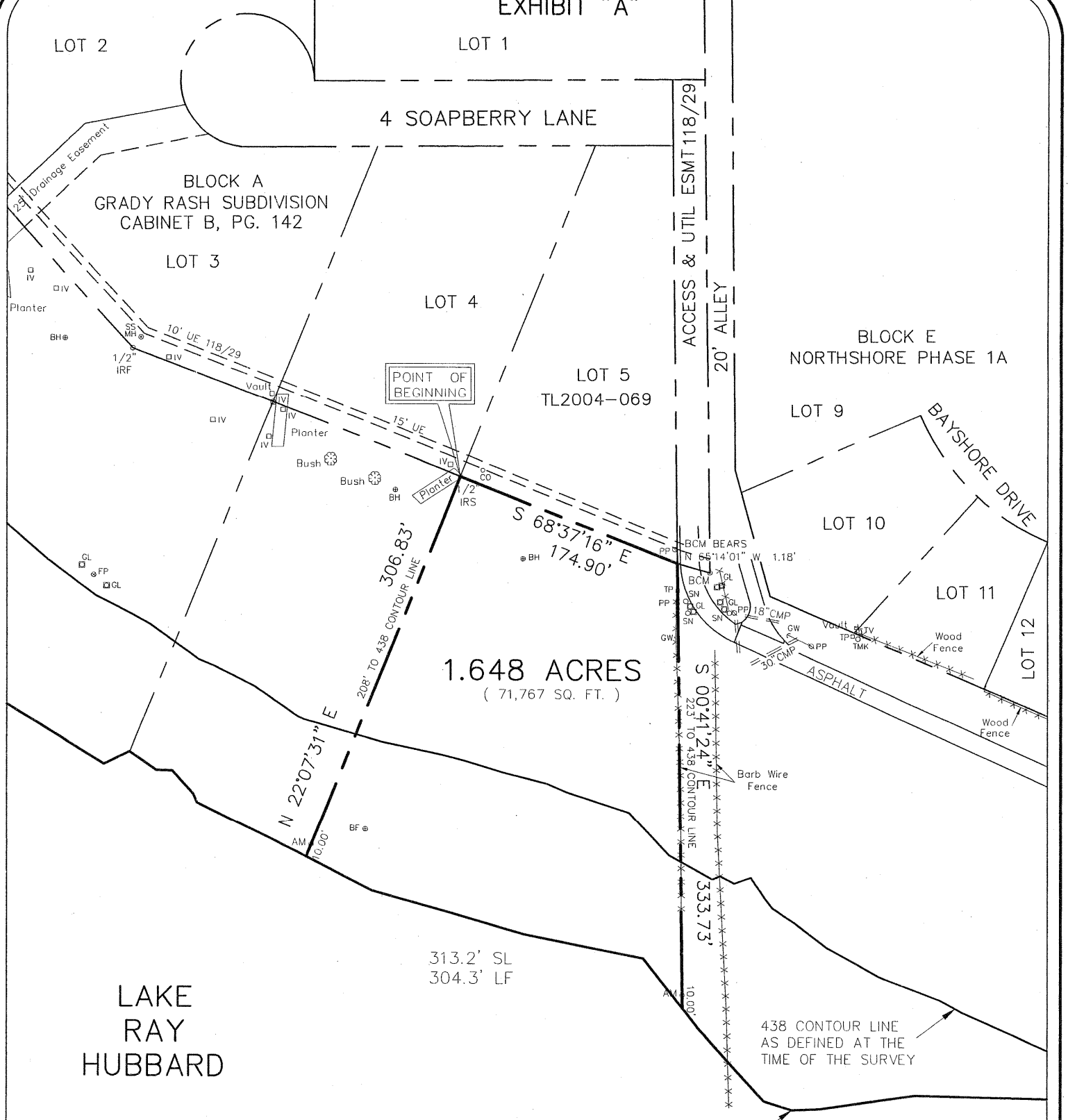

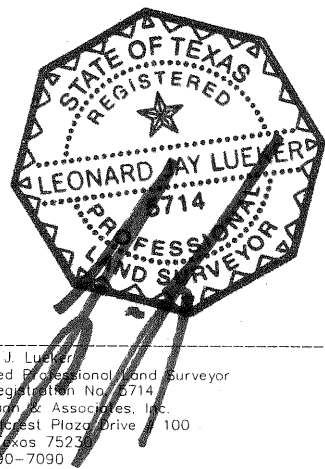

SUB LEASE DESCRIPTION
PROJECT NO. TL2004-069

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most southwesterly corner of LOT 5, BLOCK A of GRADY RASH SUBDIVISION, an addition to the City of Rockwall as recorded in Cabinet B, Page 142 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the southerly line of said LOT 5, BLOCK A South 68 deg 37 min 16 sec East a distance of 174.90 feet to a point from which a brass-capped monument found bears North 65 deg 14 min 01 sec West a distance of 1.18 feet for corner at the most southeasterly corner of said LOT 5, BLOCK A;

THENCE departing the southerly line of said LOT 5, BLOCK A South 00 deg 41 min 24 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 323.73 feet, continuing in all a distance of 333.73 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 313.2 feet to a point for corner;

THENCE departing said 435.5 contour line North 22 deg 07 min 31 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 306.83 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 1.648 acres or 71,767 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
