SUB LEASE DESCRIPTION PROJECT NO. TL2004-072

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found at the most northwesterly corner of LOT 23, BLOCK A of STONEBRIDGE MEADOWS PHASE 5, an addition to the City of Rockwall as recorded in Cabinet A, Page 388 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 23, BLOCK A South 19 deg 06 min 39 sec East a distance of 94.95 feet to a 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 23, BLOCK A;

THENCE departing the westerly line of said LOT 23, BLOCK A South 70 deg 53 min 21 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 317.03 feet, continuing in all a distance of 327.00 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 134.5 feet to a point for corner;

THENCE departing said 435.5 contour line North 70 deg 53 min 21 sec East a distance of 304.16 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.697 acres or 30,371 square feet of land, more or less.
