SUB LEASE DESCRIPTION PROJECT NO. TL2004-085

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1" iron pipe found at the most northwesterly corner of LOT 10, BLOCK A of STONEBRIDGE MEADOWS PHASE ONE, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 10, BLOCK A South 08 deg 33 min 41 sec East a distance of 100.00 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 10, BLOCK A;

THENCE departing the westerly line of said LOT 10, BLOCK A South 81 deg 26 min 19 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 128.08 feet, continuing in all a distance of 138.17 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 105.5 feet to a point for corner;

THENCE departing said 435.5 contour line North 81 deg 26 min 19 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 104.61 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.279 acres or 12,139 square feet of land, more or less.
