SUB LEASE DESCRIPTION PROJECT NO. TL2004-092

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 12, BLOCK C of ROYAL PARK PLACE, an addition to the City of Rockwall as recorded in Cabinet A, Page 260 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 12, BLOCK C South 22 deg 07 min 57 sec East a distance of 160.24 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 12, BLOCK C;

THENCE departing the westerly line of said LOT 12, BLOCK C South 74 deg 46 min 07 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 128.15 feet, continuing in all a distance of 138.21 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 162.4 feet to a point for corner;

THENCE departing said 435.5 contour line North 74 deg 46 min 07 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.01 feet, continuing in all a distance of 115.52 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.472 acres or 20,540 square feet of land, more or less.
