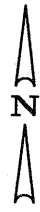

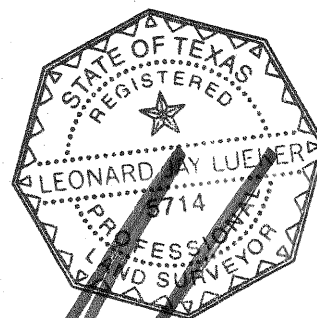

SUB LEASE DESCRIPTION  
PROJECT NO. TL2004-098

STATE OF TEXAS  
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 3/8 inch iron rod found at the most northwesterly corner of LOT 6, BLOCK C of ROYAL PARK PLACE, an addition to the City of Rockwall as recorded in Cabinet A, Page 260 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 6, BLOCK C South 22 deg 07 min 57 sec East a distance of 105.27 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 6, BLOCK C;

THENCE departing the westerly line of said LOT 6, BLOCK C South 59 deg 32 min 55 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 125.85 feet, continuing in all a distance of 135.79 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 111.7 feet to a point for corner;

THENCE departing said 435.5 contour line North 61 deg 17 min 54 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.03 feet, continuing in all a distance of 150.25 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.347 acres or 15,100 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
