SUB LEASE DESCRIPTION PROJECT NO. TL2004-099

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 5, BLOCK C of ROYAL PARK PLACE, an addition to the City of Rockwall as recorded in Cabinet A, Page 260 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 5, BLOCK C South 22 deg 07 min 57 sec East a distance of 118.39 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 5, BLOCK C;

THENCE departing the westerly line of said LOT 5, BLOCK C South 59 deg 02 min 44 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 111.24 feet, continuing in all a distance of 121.35 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 127.2 feet to a point for corner;

THENCE departing said 435.5 contour line North 59 deg 32 min 55 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.94 feet, continuing in all a distance of 135.79 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.341 acres or 14,868 square feet of land, more or less.
