## EXHIBIT "B"

SUB LEASE DESCRIPTION PROJECT NO. TL2004-101

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 5, BLOCK H of RIDGE ROAD VILLAGE 2ND INSTALLMENT, an addition to the City of Rockwall as recorded in Cabinet A, Page 107 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 5, BLOCK H as follows:

South 14 deg 12 min 20 sec West a distance of 83.62 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner;

South 29 deg 10 min 32 sec East a distance of 152.35 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 5, BLOCK H;

THENCE departing the westerly line of said LOT 5, BLOCK H South 60 deg 49 min 28 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 192.16 feet, continuing in all a distance of 208.69 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 250.4 feet to a point for corner;

THENCE departing said 435.5 contour line North 58 deg 24 min 40 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.04 feet, continuing in all a distance of 243.66 feet to the POINT OF BEGINNING:
