SUB LEASE DESCRIPTION PROJECT NO. TL2004-110

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 5, BLOCK 1 of RIDGE ROAD VILLAGE 3RD AND 4TH INSTALLMENTS, an addition to the City of Rockwall as recorded in Cabinet A, Page 125 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 5, BLOCK 1 South 18 deg 51 min 32 sec East a distance of 100.00 feet to a 60D nail set for corner at the most southwesterly corner of said LOT 5, BLOCK 1;

THENCE departing the westerly line of said LOT 5, BLOCK 1 South 71 deg 08 min 28 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 132.77 feet, continuing in all a distance of 142.72 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 104.0 feet to a point for corner;

THENCE departing said 435.5 contour line North 71 deg 08 min 28 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.97 feet, continuing in all a distance of 169.99 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.364 acres or 15,845 square feet of land, more or less.
