SUB LEASE DESCRIPTION PROJECT NO. TL2004-127

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 9, BLOCK E of LAKE RAY HUBBARD ESTATES, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 9, BLOCK E South 01 deg 02 min 22 sec East a distance of 85.00 feet to 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 9, BLOCK E;

THENCE departing the westerly line of said LOT 9, BLOCK E South 88 deg 57 min 38 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 109.51 feet, continuing in all a distance of 119.61 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 92.0 feet to a point for corner;

THENCE departing said 435.5 contour line North 88 deg 57 min 38 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.02 feet, continuing in all a distance of 149.97 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.262 acres or 11,397 square feet of land, more or less.
