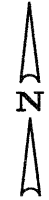

SUB LEASE DESCRIPTION  
PROJECT NO. TL2004-128

STATE OF TEXAS  
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 10, BLOCK E of LAKE RAY HUBBARD ESTATES, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 10, BLOCK E South 01 deg 02 min 22 sec East a distance of 35.33 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 10, BLOCK E;

THENCE departing the westerly line of said LOT 10, BLOCK E South 88 deg 57 min 38 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 110.08 feet, continuing in all a distance of 120.19 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 39.8 feet to a point for corner;

THENCE departing said 435.5 contour line North 88 deg 57 min 38 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.10 feet, continuing in all a distance of 119.61 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.098 acres or 4,249 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
