SUB LEASE DESCRIPTION PROJECT NO. TL2004-129

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 1, BLOCK A of THE ESTATES OF COAST ROYALE NO. 2, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 1, BLOCK A South 12 deg 42 min 17 sec West a distance of 121.59 feet to a 5/8 inch iron rod found for corner at the most southwesterly corner of said LOT 1, BLOCK A;

THENCE departing the westerly line of said LOT 1, BLOCK A North 48 deg 28 min 22 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 124.49 feet, continuing in all a distance of 135.19 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 29.1 feet to a point for corner;

THENCE departing said 435.5 contour line North 88 deg 57 min 38 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.11 feet, continuing in all a distance of 120.19 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.201 acres or 8,744 square feet of land, more or less.
