SUB LEASE DESCRIPTION PROJECT NO. TL2004-135

STATE OF TEXAS

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 1, BLOCK D of LAKE RIDGE PARK, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 1, BLOCK D South 12 deg 36 min 14 sec West a distance of 145.59 feet to a 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 1, BLOCK D;

THENCE departing the westerly line of said LOT 1, BLOCK D North 63 deg 07 min 07 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 106.89 feet, continuing in all a distance of 116.83 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 168.4 feet to a point for corner;

THENCE departing said 435.5 contour line South 49 deg 02 min 53 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 78.71 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.313 acres or 13,643 square feet of land, more or less.
