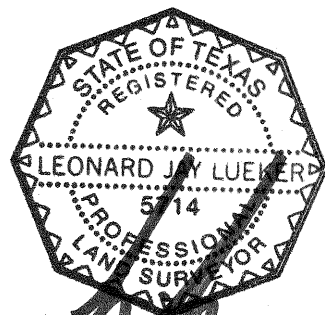

SUB LEASE DESCRIPTION
PROJECT NO. TL2004-137

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 3, BLOCK D of LAKE RIDGE PARK, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 3, BLOCK D South 12 deg 36 min 14 sec West a distance of 61.15 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 3, BLOCK D;

THENCE departing the westerly line of said LOT 3, BLOCK D North 51 deg 42 min 27 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 114.54 feet, continuing in all a distance of 124.31 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 124.1 feet to a point for corner;

THENCE departing said 435.5 contour line South 58 deg 28 min 56 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.81 feet, continuing in all a distance of 166.52 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.202 acres or 8,807 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
