

SUB LEASE DESCRIPTION PROJECT NO. TL2004-138

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 4, BLOCK D of LAKE RIDGE PARK, an addition to the City of Rockwall;

THENCE along the westerly line of said LOT 4, BLOCK D South 12 deg 36 min 14 sec West a distance of 50.95 feet to a point from which a brass—capped monument found bears North 86 deg 54 min 55 sec West a distance of 1.32 feet for corner;

THENCE South 80 deg 36 min 34 sec West passing the most westerly southwesterly corner of said LOT 4, BLOCK D at a distance of 31.46 feet, continuing in all a distance of 45.99 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most northeasterly corner of LOT 5, BLOCK D of said LAKE RIDGE PARK;

THENCE North 43 deg 42 min 46 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 120.42 feet, continuing in all a distance of 130.28 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 285.1 feet to a point for corner;

THENCE departing said 435.5 contour line South 51 deg 42 min 27 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.77 feet, continuing in all a distance of 124.31 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.134 acres or 5,839 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
