SUB LEASE DESCRIPTION PROJECT NO. TL2004-143

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northeasterly corner of LOT 5R, BLOCK C of REPLAT OF TURTLE COVE ADDITION, an addition to the City of Rockwall as recorded in Cabinet C, Page 164 of the Plat Records of Rockwall County, Texas;

THENCE along the northerly line of said LOT 5R, BLOCK C South 61 deg 58 min 36 sec West a distance of 71.03 feet to a 5/8 inch iron rod found for corner at the most northwesterly corner of said LOT 5R, BLOCK C;

THENCE departing the northerly line of said LOT 5R, BLOCK C North 18 deg 15 min 11 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 434.32 feet, continuing in all a distance of 444.37 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 99.4 feet to a point for corner;

THENCE departing said 435.5 contour line South 18 deg 15 min 11 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 488.56 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.736 acres or 32,058 square feet of land, more or less.
