

## EXHIBIT "B"

SUB LEASE DESCRIPTION PROJECT NO. TL2004-148

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 68, BLOCK A of TURTLE COVE ADDITION SECOND REPLAT, an addition to the City of Rockwall as recorded in Cabinet F, Page 365 of the Plat Records of Rockwall County, Texas;

THENCE along the westerly line of said LOT 68, BLOCK A as follows:

South 18 deg 10 min 26 sec West a distance of 108.71 feet to a brass—capped monument found for corner;

South 19 deg 40 min 19 sec East a distance of 11.23 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southwesterly corner of said LOT 68, BLOCK A;

THENCE departing the westerly line of said LOT 68, BLOCK A South 84 deg 41 min 08 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 420.16 feet, continuing in all a distance of 430.24 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 393.6 feet to a point for corner;

THENCE departing said 435.5 contour line South 64 deg 13 min 01 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.07 feet, continuing in all a distance of 516.21 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 2.381 acres or 103,714 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
