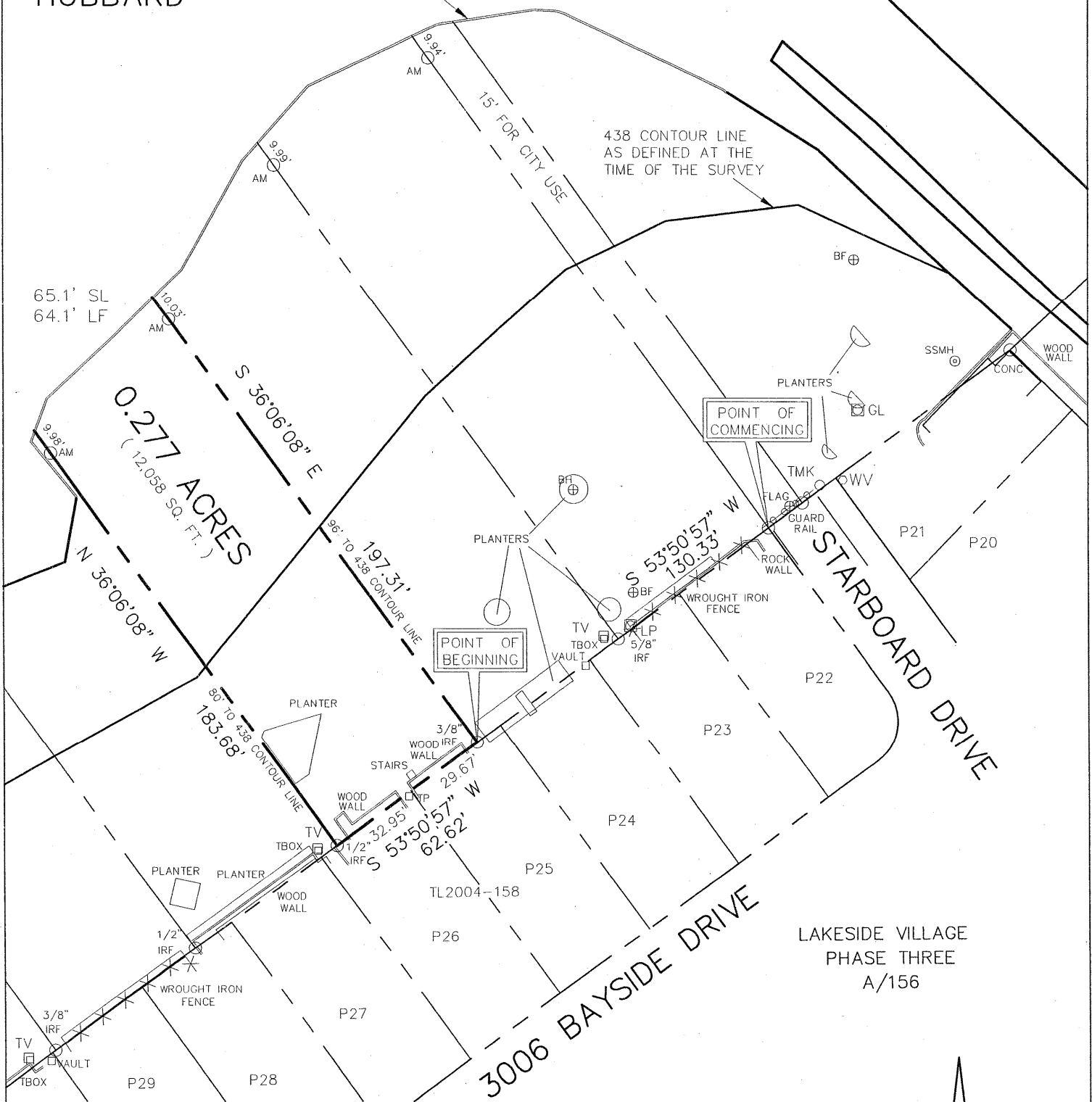

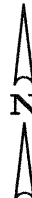
435.5 CONTOUR LINE

SUB LEASE DESCRIPTION
PROJECT NO. TL2004-158

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

COMMENCING at a point for the most northeasterly corner of LOT P22 of LAKESIDE VILLAGE PHASE THREE, an addition to the City of Rockwall as recorded in Cabinet A, Page 156 of the Plat Records of Rockwall County, Texas, said point being in the southwesterly right-of-way line of STARBOARD DRIVE (30' right-of-way);

THENCE departing the southwesterly right-of-way line of said STARBOARD DRIVE South 53 deg 50 min 57 sec West a distance of 130.33 feet to a 3/8 inch iron rod found for the POINT OF BEGINNING, said point being in the northerly line of LOT P25 of said LAKESIDE VILLAGE PHASE THREE;

THENCE South 53 deg 50 min 57 sec West passing the most northwesterly corner of said LOT P25 at a distance of 29.67 feet, continuing in all a distance of 62.62 feet to a 1/2 inch iron rod found for corner in the northerly line of LOT P26 of said LAKESIDE VILLAGE PHASE THREE;

THENCE departing the northerly line of said LOT P26 North 36 deg 06 min 08 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 173.70 feet, continuing in all a distance of 183.68 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 65.1 feet to a point for corner;

THENCE departing said 435.5 contour line South 36 deg 06 min 08 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.03 feet, continuing in all a distance of 197.31 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.277 acres or 12,058 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
