SUB LEASE DESCRIPTION PROJECT NO. TL2004-171

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land lease to the City of Rockwall and being more particularly described as follows;

BEGINNING at a $\frac{1}{2}$ inch iron rod found at the most northwesterly corner of LOT 39, BLOCK F of the HILLSIDE PHASE 5 AT THE SHORES, an addition to the City of Rockwall as recorded in Cabinet D, Page 323 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the westerly line of said LOT 39, BLOCK F South 06 deg 55 min 43 sec East a distance of 65.00 feet to a $\frac{1}{2}$ inch iron rod set with a red plastic cap stamped "W.A.I." for the most southwesterly corner of said LOT 39, BLOCK F;

THENCE departing the westerly line of said LOT 39, BLOCK F South 83 deg 04 min 17 sec West passing a 3 ½ inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 388.31 feet continuing in all a distance of 398.36 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of the said 435.5 contour line in a northerly direction a distance of 65.1 feet to a point for corner;

THENCE departing the said 435.5 contour line North 83 deg 04 min 17 sec East passing a 3 ½ inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.96 feet continuing in all a distance of 395.60 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.592 acres or 25,804 square feet of land more or less.
