SUB LEASE DESCRIPTION PROJECT NO. TL2004-176

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 5/8 inch iron rod found at the most northeasterly corner of LOT 6, BLOCK A of TURTLE COVE ADDITION PHASE III, an addition to the City of Rockwall as recorded in Cabinet D, Page 253 of the Plat Records of Rockwall County, Texas;

THENCE along the northerly line of said LOT 6, BLOCK A South 46 deg 33 min 31 sec West a distance of 60.00 feet to a 5/8 inch iron rod found for corner at the most northwesterly corner of said LOT 6, BLOCK A;

THENCE departing the northerly line of said LOT 6, BLOCK A North 43 deg 26 min 29 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 181.25 feet, continuing in all a distance of 191.30 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 61.8 feet to a point for corner;

THENCE departing said 435.5 contour line South 43 deg 26 min 29 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.05 feet, continuing in all a distance of 188.61 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.267 acres or 11,632 square feet of land, more or less.
