

SUB LEASE DESCRIPTION PROJECT NO. TL2004-182

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most southwesterly corner of LOT 4, BLOCK A of CHANDLERS LANDING PHASE 18, SECTION 2, an addition to the City of Rockwall as recorded in Cabinet B, Page 198 of the Plat Records of Rockwall County, Texas;

THENCE North 72 deg 47 min 43 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 87.21 feet, continuing in all a distance of 97.07 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northeasterly direction a distance of 98.8 feet to a point for corner;

THENCE departing said 435.5 contour line South 63 deg 03 min 30 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.80 feet, continuing in all a distance of 54.94 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner in the westerly line of said LOT 4, BLOCK A;

THENCE along the westerly line of said LOT 4, BLOCK A as follows:

South 43 deg 43 min 38 sec West a distance of 18.87 feet to a 1/2 inch iron rod found for corner;

South 04 deg 45 min 49 sec East a distance of 72.16 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.142 acres or 6,187 square feet of land, more or less. This Sub Lease description was prepared from an actual on the ground survey performed in the field from January 2004 to December 2004 and is subject to change due to natural and / or man made changes after the survey.
