SUB LEASE DESCRIPTION PROJECT NO. TL2004-185

STATE OF TEXAS
COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 13, BLOCK A of CHANDLERS LANDING PHASE 18, SECTION 2, an addition to the City of Rockwall as recorded in Cabinet C, Page 46 of the Plat Records of Rockwall County, Texas;

THENCE along the westerly line of said LOT 13, BLOCK A South 17 deg 16 min 16 sec West a distance of 80.00 feet to a 1/2 inch iron rod found for corner at the most southwesterly corner of said LOT 13, BLOCK A;

THENCE departing the westerly line of said LOT 13, BLOCK A North 72 deg 43 min 44 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 22.57 feet, continuing in all a distance of 32.68 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 85.1 feet to a point for corner;

THENCE departing said 435.5 contour line South 72 deg 43 min 44 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 9.96 feet, continuing in all a distance of 50.84 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.078 acres or 3,377 square feet of land, more or less.
