SUB LEASE DESCRIPTION PROJECT NO. TL2004-186

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a point from which a 1/2 inch iron rod found bears North 82 deg 42 min 22 sec East a distance of 0.86 feet, said point being the most northwesterly corner of LOT 14, BLOCK A of CHANDLERS LANDING PHASE 18, SECTION 2, an addition to the City of Rockwall as recorded in Cabinet C, Page 46 of the Plat Records of Rockwall County, Texas;

THENCE along the westerly line of said LOT 14, BLOCK A South 17 deg 16 min 16 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 83.00 feet, continuing in all a distance of 93.00 feet to a to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 119.6 feet to a point for corner;

THENCE departing said 435.5 contour line South 72 deg 43 min 44 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.11 feet, continuing in all a distance of 32.68 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.047 acres or 2,044 square feet of land, more or less.
