SUB LEASE DESCRIPTION PROJECT NO. TL2004-189

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 17, BLOCK A of CHANDLERS LANDING PHASE 18, SECTION 2, an addition to the City of Rockwall as recorded in Cabinet C, Page 46 of the Plat Records of Rockwall County, Texas;

THENCE along the westerly line of said LOT 17, BLOCK A as follows:

South 25 deg 32 min 32 sec East a distance of 73.63 feet to a to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner;

North 44 deg 22 min 21 sec East a distance of 22.73 feet to a 1/2 inch iron rod found for corner;

South 40 deg 38 min 28 sec East a distance of 17.00 feet to a 3/8 inch iron rod found for corner at the most southwesterly corner of said LOT 17, BLOCK A;

THENCE departing the westerly line of said LOT 17, BLOCK A South 54 deg 42 min 47 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 35.12 feet, continuing in all a distance of 45.12 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 89.3 feet to a point for corner;

THENCE departing said 435.5 contour line North 60 deg 51 min 29 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.01 feet, continuing in all a distance of 34.76 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.065 acres or 2,812 square feet of land, more or less.
