SUB LEASE DESCRIPTION PROJECT NO. TL2004-192

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most northwesterly corner of LOT 21—R, BLOCK A of REPLAT OF LOT 21, BLOCK A OF CHANDLERS LANDING PHASE 17, an addition to the City of Rockwall as recorded in Cabinet E, Page 193 of the Plat Records of Rockwall County, Texas (PRRCT), said point being the most southwesterly corner of LOT 3, BLOCK A of SIGNAL RIDGE NO. 4, an addition to the City of Rockwall according to the plat recorded in Cabinet B, Page 91 (PRRCT);

THENCE along the westerly line of said LOT 21-R, BLOCK A South 45 deg 50 min 24 sec West a distance of 120.42 feet to a 5/8 inch iron rod found for corner at the most southwesterly corner of said LOT 21-R, BLOCK A;

THENCE departing the westerly line of said LOT 21—R, BLOCK A North 57 deg 34 min 37 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 200.51 feet, continuing in all a distance of 210.51 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northerly direction a distance of 153.9 feet to a point for corner;

THENCE departing said 435.5 contour line South 57 deg 22 min 35 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 284.06 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 0.683 acres or 29,763 square feet of land, more or less.
