AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF ROCKWALL, ROCKWALL COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE THE HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Rockwall, Texas, has been signed by the majority of the inhabitants of such described territory who are qualified to vote for members of the State Legislature; and,

WHEREAS, said land is adjoining the City of Rockwall and said petition was presented to the Mayor and City Council of the City of Rockwall requesting the annexation of said territory to said City; and

WHEREAS, the members of the City Council of the City of Rockwall have approved the petition requesting the annexation of said territory; NOW, THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKWALL, TEXAS:

SECTION 1. That the following described property to-wit:

Extension No. 1 North:

BEGINNING: At a stake in the Northwest corner of present City limits extension No. 2 South;

THENCE: North, one-half mile West and parallel present City Limits a distance of 12595 feet, continuing 2640 feet a distance of 15235 feet in all to a stake for a corner on the East side of Squabble Creek in the N. B. Willess 100 acre tract of land;

THENCE: East 10190 feet distance to a stake in County Road, East of State Highway No. 205;

THENCE: South 2640 feet distance to a stake in the North line of the present City Limits;

and the same are hereby extended to include the above described territory within the city limits of the City of Rockwall, and the same shall hereafter be included within the territorial limits of said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of ~~other~~ citizens of the City of Rockwall, and they shall be bound by the Acts, Ordinances, Resolutions and Regulations of said City.



SECTION 2. That this ordinance shall take effect from and after its passage as the law in such cases provides.

"EXHIBIT A"

PROPOSED FIELD NOTES FOR THE CITY LIMITS OF THE CITY OF ROCKWALL, TEXAS:

Extension No. 1 North:

BEGINNING: At a stake in the Northwest corner of present City Limits, extension No. 2 South:

THENCE: North, ^{13,295 feet} one-half mile West and parallel present City Limits a distance of ~~12,200~~ feet, continuing 2640 feet a distance of ^{15,735 feet} ~~12,740~~ feet in all to a stake for a corner on the East side of Squabble Creek in the N. B. Willis 100 acre tract of land;

THENCE: East 10190 feet distance to a stake in County Road, East of State Highway No. 205;

THENCE: South 2640 feet distance to a stake in the North line of the present City Limits;

THENCE: West 7550 distance with North line of present City Limits to the Northwest corner of said City Limits;

THENCE: South ^{12,595 feet} ~~12,100~~ feet distance with present City Limits West line to a stake for a corner;

THENCE: West 2640 feet distance to the place of beginning.

Proposed City Limit line running parallel and one-half mile distance from the present City Limit line.
