AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY
TO THE CITY OF ROCKWALL, ROCKWALL COUNTY, TEXAS, AND EXTENDING
THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREIN—
AFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING
TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE
RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING ALL IN—
HABITANTS BY ALL THE ACTS, ORDINANCES AND REGULATIONS OF SAID
CITY; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR THE PUBLI—
CATION OF SAID ORDINANCE; AND PROVIDING FOR THE EFFECTIVE DATE
OF SAID ORDINANCE.

WHEREAS, the following described land is adjoining the present City Limits of the City of Rockwall and the members of the City Council of the City of Rockwall have concluded that said area should be annexed and made a part of the City of Rockwall, Texas; and,

WHEREAS, a petition signed by the owners of all the following described property has been filed with the City Secretary of the City of Rockwall, requesting that the City of Rockwall annex the following described property; and,

WHEREAS, after the holding of a public hearing under the provisions of Article 970a, Revised Civil Statutes of Texas, the City Council of the City of Rockwall has decided that the following described property should be annexed to the City of Rockwall:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKWALL, TEXAS:

SECTION 1. That the following described territory be and the same is hereby annexed to the City of Rockwall, Rockwall County, Texas, and the boundary limits of the City of Rockwall be, and the same are hereby extended to include the following described territory within the City Limits of the City of Rockwall, and the same hereafter shall be included within the territorial limits of said City, and the inhabitants thereof hereafter shall be entitled

to all rights and privileges of other citizens of the City of Rockwall, and shall be bound by the acts, ordinances, resolutions and regulations of said City. That the territory to be so annexed is more particularly described as follows. to-wit:

BEING a tract of land in the J. R. Johnson Survey, Abst. No. 128, W. H. Barnes Survey, Abst. No. 26, and the W. H. Baird Survey, Abst. No. 25, and being part of tract No. 2 described in a deed conveyed to Cambridge Co. recorded in Vol. 105, Pg. 505, part of 26.75 acre tract conveyed to Cambridge Co. by deed recorded in Vol. 112, Pg. 325, and part of a 167.5 acre tract conveyed to Cambridge Co. by deed recorded in Vol. 102, Pg. 18, all being recorded in the Deed Records, Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a point for a corner on the Northeast line of State Hwy. No. 205 and on the Southwest line of the above described 26.75 acre tract;

THENCE East a distance of 2057.29 feet to a point for a corner;

THENCE South a distance of 2150.0 feet to a point for a corner;

THENCE West a distance of 743.40 feet to a point for a corner on the Northeast R.O.W. line of State Hwy. No. 205, said corner being on a circular curve to the right having a partial central angle of 8° 59' 17" and a radius of 5679.6 feet;

THENCE with the Northeast R.O.W. line of State Hwy. No. 205 as follows:

Northwesterly: Around said curve a distance of 890.95 feet to the point of tangency of said curve for a corner; North 29° 50' 37" West a distance of 448.36 feet to a point for a corner;

point for a corner; North 60° 09' 23" East a distance of 10.0 feet to a point for a corner;

point for a corner; North 29° 50' 37" West a distance of 300.64 feet to a point for a corner:

point for a corner; South 60° 09' 23" West a distance of 10.0 feet to a point for a corner; North 29° 50' 37" West a distance of 882.42 feet to

North 29° 50' 37" West a distance of 882.42 feet to the Point of Beginning and containing 70.592 acres of land.

SECTION 2. That it is not the intention of the City of Rockwall to annex any territory not legally subject to being annexed by said City, and should any portion of the above described territory not be subject to legal annexation by the City of Rockwall, such fact will not prevent the City from annexing such territory which is above described and is subject to legal annexation by the City, and it is the intention of the City of Rockwall to annex only such territory as may be legally annexed by it within the limits of the above described area.

SECTION 3. That this ordinance shall take effect from and after its passage as the law and statutes in such cases provide.

SECTION 4. That a copy of this ordinance, together with a copy of the Petition requesting the annexation of such territory, shall be filed in the Deed Records of Rockwall County, Texas, and the City Secretary shall certify that the copy to be filed is a true and correct copy of said ordinance.
