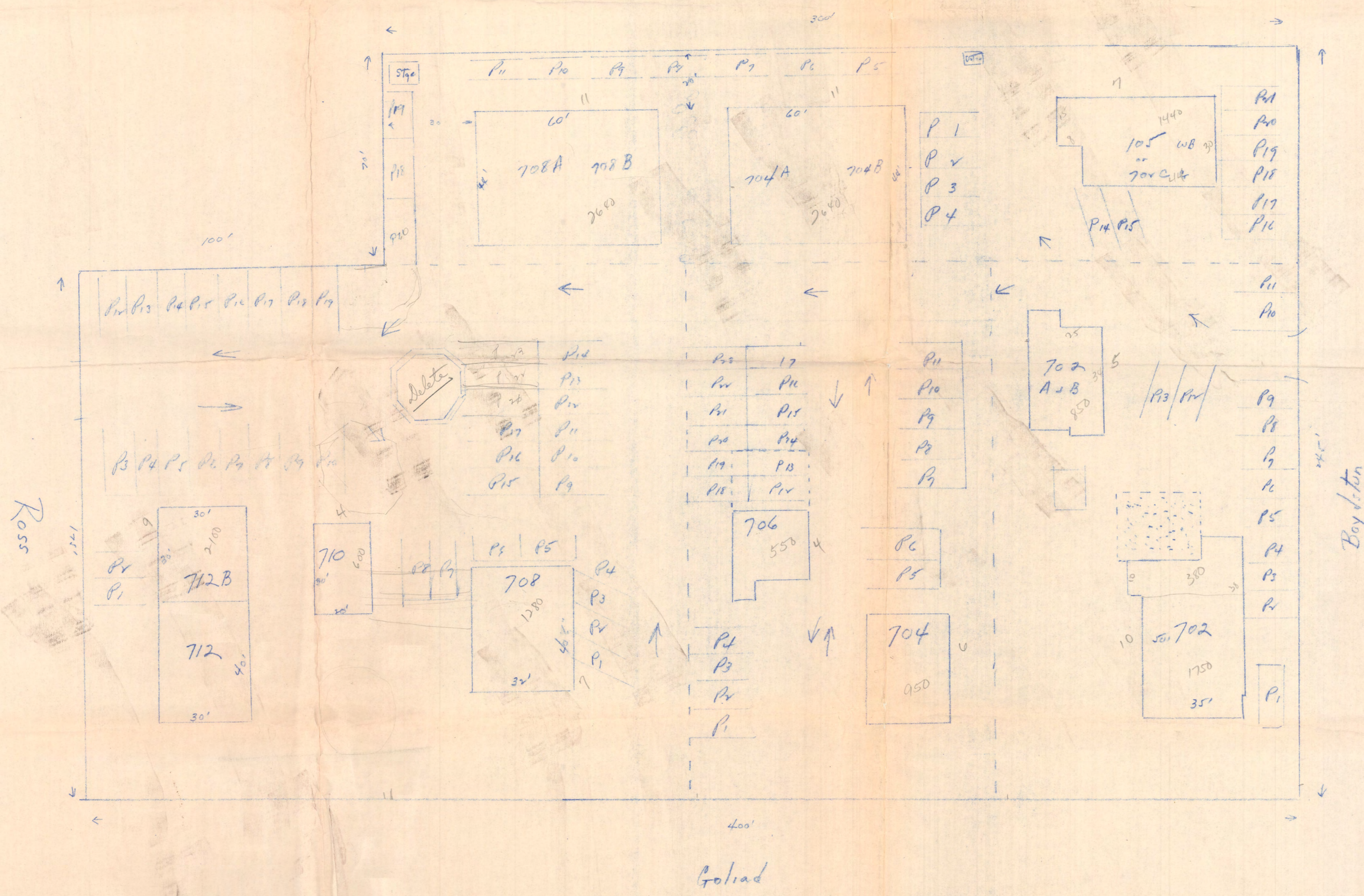

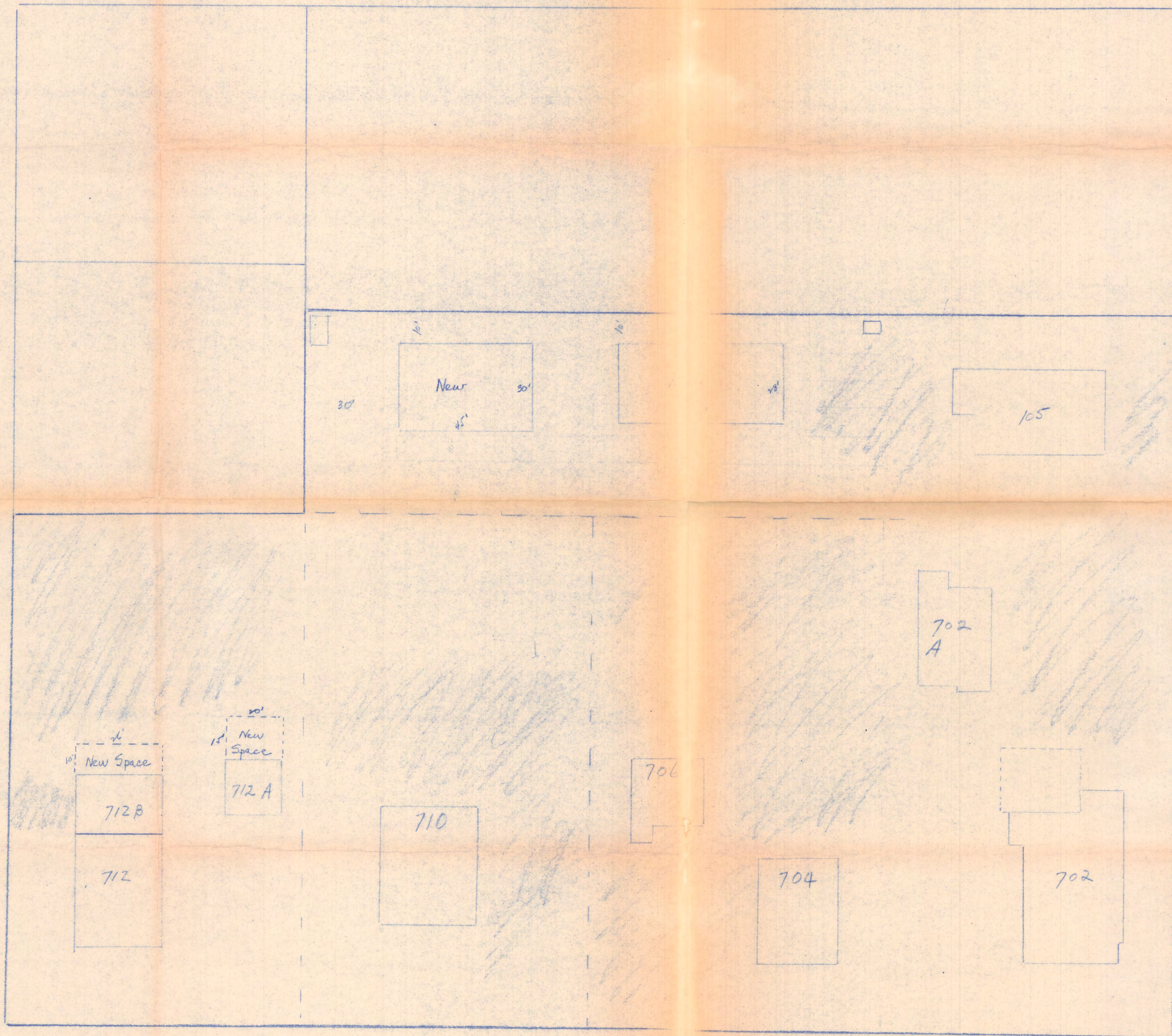

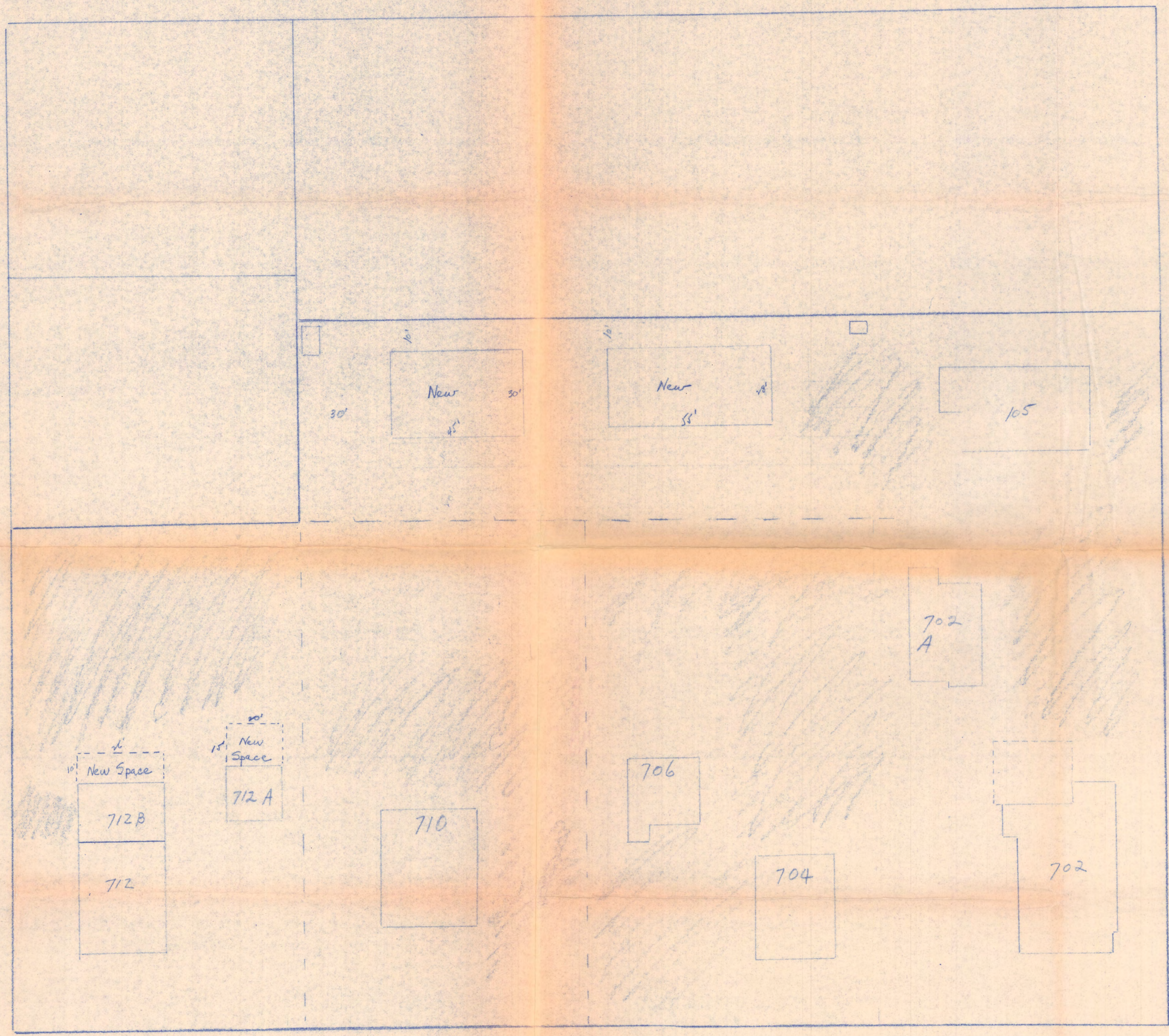

The increased footage is ten feet by twenty-six feet to 712 B and fifteen feet by twenty feet to 712 A. Off-street parking requirements have already been met.


I submit on the site plan also the location of two buildings to be moved onto the rear of the property. These are frame cottages in keeping with the overall concept and decor of Goliad Place.
